Once the scenarios are described, the planners can choose the preferred scenario and then identify action steps that will help to make the preferred scenario the reality in the future. These exercises were particularly timely and appropriate for the College as the

Trustees address the question of what role the College should play beyond recognizing outstanding achievements in law practice management. 

**Del Sesto Receives** Pro Bono Publico Award

Providence attorney Ronald W. Del Sesto has been awarded the Pro Bono Publico Award by the Washington-based National

Italian American Bar Association. Del Sesto was selected for his long-term volunteering of his legal services to advance the cause of Americans of Italian descent. NIABA, in its 20 years, has only selected three individuals for such an award.

Del Sesto is the Honorary Vice Consul of Italy-Providence, a director of the Washington-based National Italian American Foundation, a commissioner of the American and Italian Cultural Exchange Commission created by the state of Rhode Island, and a founding director and past president of the Justinian Law Society of Rhode Island.

Del Sesto and his wife, Deborah, frequent visitors to Italy, created the Umbria Relief Fund in 1997 to help the victims of that year's earthquake in the vicinity of Assisi, founded Cinema e Cucina Italiana, which promotes Italian cinema and Italian food, and founded and serve as webmasters of www.webitalia.com. Del Sesto, a graduate of Georgetown University and Boston College Law School, is a Uniform Law Commissioner.

## 2002 Annual Meeting Program – **Future Scenario Planning**

As described in Chuck's Notes at the beginning of this newsletter, after a

presentation about scenario planning by Futurist Stuart Forsyth

(www.legalfuturist.com), the Fellows worked in small groups to develop several scenarios describing what the legal profession might look like in 2015. Stuart emphasized that future planning should be plausible, that we were not to make "predictions" but to examine possibilities. The groups were asked to develop scenarios based on the following questions:

- Who will deliver legal services in 2015?
- What will be the demand for services in 2015?
- Where will legal services be delivered?
- · How will legal services be delivered?

Each table worked with different assumptions: legal services would/would not continue to be delivered by lawyers: services would continue to look like traditional legal practice; services would be very different and be delivered in different settings; and the like. We learned that we can think about the future in meaningful ways, we can take actions to foster the future we prefer, we need to include younger people in the planning (many of us won't be active in the profession in 2015!), and we must not steer the boat by the wake. Precedent may not have much power when we factor in the wildcards and uncertainties of today's world.

We are attempting to collect a summary of each table's discussion and hope to have it available on the COLPM website in the future.
