The 2026 Futures Conference invites leaders across the legal ecosystem to New York City for an inspiring, forward-looking experience that blends community, innovation, and human-centered leadership, highlighted by the return of the College’s Black-Tie Gala to honor the Class of 2026 Fellows and the Michael Mills InnovAction Award winner. Over two days of keynotes, hands-on labs, intergenerational exchange, and thoughtful peer collaboration, attendees will explore the forces reshaping legal service, including the rise of intelligent systems, shifting client expectations, evolving professional identities, and new opportunities to expand access to justice, while emphasizing the enduring importance of human judgment, creativity, and leadership in guiding change.
